Sub:- Creation of 663 posts of Security Coys in 03 IR Battalions (221 per IR Bn) and outsourcing of services of Water Carrier, Sweeper, Cook, Dhobi & Barber in lieu of abolition of 330 sanctioned posts of Engineering Coys in 03 SIR Battalions.

Sir,

I am directed to convey the sanction of the Governor for creation of 663 (six hundred sixty three) posts of Security Coys in three (3) India Reserve Battalions @ 221 per each India Reserve Battalion of different categories in the level of pay noted against each with usual D.A and other allowances as sanctioned by the Government time to time except in the case of Water Carrier, Sweeper, Cook, Dhobi & Barber whose services will be outsourced as specified in the table below. The posts are sanctioned from the date those are actually filled up.
